To: Mahoning County Saddle Horse Youth & Junior Fair Youth Exhibitors,
Parents and/or Guardians, and Youth Advisors
Re: Policy for 2019 Saddle Horse Show Participation & Junior Fair Exhibition
March 16, 2019

"The Mahoning County Saddle Horse & Junior Fair Show Exhibitor shall be responsible for the continuous care, grooming, and preparation of the horse(s) entered in the 2019 Saddle Horse & Junior Fair Shows", as stated in the Junior Fair Section of the Senior Fair Premium Book and is referred to as the "Exhibitor Only Policy". The mission of the Junior Fair & the Saddle Horse Program is to provide educational opportunities for youth by encouraging "Learning By Doing" where the youth exhibitor can learn and gain personal experience with the "hands on" involvement offered through the preparation of their horse(s) during the year prior to exhibition, and exhibition of their project in the Junior Fair Show. All youth exhibitors, along with their parent and/or guardian will be informed of the guidelines for the animal(s) they intend to exhibit. Youth exhibitors and/or their parent / guardian are responsible for obtaining a copy of these guidelines and will be expected to read and verify that these guidelines were received and understood. The Junior Fair, with the support of the Mahoning County Saddle Horse Committee and 4-H Advisory Committee, **will not tolerate** the breaking of these guidelines. Only special circumstance, which require prior approval from the committee and Junior Fair representative, will be the exception. With the adoption of this policy, infractions to the guidelines will be handled accordingly. **The Saddle Horse Show & Junior Fair Guidelines have been established to provide equal opportunity for competitive excellence for all youth.**

Saddle Horse participants & Junior Fair Exhibitors shall assume liability for care and control of their horse(s), and their personal actions at all times. Youth and parents participating assume the obligation to understand the risks involved in working with Saddle Horse. In addition to the attached guidelines, youth and parents understand the responsibility of knowing the guidelines included in the Mahoning County Saddle Horse Show Book and the Ohio State 4-H Rule Book. The Mahoning County Agricultural Society, the Mahoning County Junior Fair, and the Mahoning County Saddle Horse Committee & associated volunteers & advisors assume no liability for loss, theft, vandalism, or negligence of an exhibitor or their designees.

The Junior Fair and the Saddle Horse Youth activities offer the greatest opportunity to allow the youth to shine and be proud of their accomplishments. We **all** (youth, parents, advisors, volunteers, and committee members) need to work to encourage and support youth involvement with their projects, and to stress the importance of both knowing and following the specific guidelines to **all** youth and parents/guardians intending to exhibit in the Saddle Horse & Junior Fair Shows. By working together, we can offer a better experience for all youth involved in Saddle Horse Shows in the future.
